CLASSES OF RIFLE AS FOLLOWS:

HISTORIC – “Any SMLE / No. 4 / No. 5 rifle, service pattern as issued, with no attachments”.

ANY IRON – “Any rifle with iron sights, with no restriction on slings (but rests may **not** be used)”.

SERVICE OPTIC – “Any rifle with optic sights with no restriction on slings. Rests may not be used. The rifle magazine may touch or rest on the forearm or on the ground. (Any forward vertical grip, if fitted, may **not** be used).”

PRACTICAL OPTIC - “Any rifle with optic sights, with no restriction on slings or rests. If any rest is utilised it must remain fitted to the rifle at all times during the match”.

Full definition of the classes, including trigger weights, can be found in the NRA Rules of Shooting, section 65, page 90, which is also available on the NRA website.
