THE NRA/ARA ADAPTIVE SHOOTING CHAMPIONSHIP 2017 **Thursday 22 June 2017**

to coincide with the Tri-Service Queen's Medal Presentations and Methuen Cup Match

The NRA/ARA Adaptive Championships 2017 will take place at Melville Range, Bisley on Thursday 22 June. The Championship comprises three matches:

- Advancing Target – A 3 stage rapid-fire match fired from a bench using a Gallery Rifle
- Mini McQueen – A sniper style match of 10 x 3 sec exposures at irregular intervals from the McQueen Castle, using a scoped .22 RF Rifle
- Snaps and Rapids – A 3 stage 25m shoot

In addition there will be a demonstration of Muzzle Loading rifles which all competitors are free to enjoy and have a go in between competitions.

There is NO ENTRY FEE for this Championship. Deadline for entries: Friday 16 June 2017.

Details of each match will be available on the day and communicated to all competitors at the mandatory Range Briefing at 09.15. All rifles, ammunition, equipment and Range Officers will be provided by the NRA/ARA.

Drinks and snacks will be available throughout, and lunch comprising sandwiches, rolls, fruit and cakes will be provided on the range from 12.00.

First Aid will be provided on the range by Met Medical.

Prizes will be awarded to the Serving and Veteran winners of each Match, and the overall Championship. Prize Giving will take place on the range at approximately 13.30.
